

# JRC WORKSHOP ON WHITE CERTIFICATES, UTILITY AND SUPPLIER OBLIGATIONS

## 31 March -1 April 2009, Centre Borschette, rue Froissart 36, 1040 Brussels

## **Background**

According to Article 4.5 of Directive 2006/32/EC on energy end-use efficiency and energy services (ESD), the Commission shall, after having reviewed and reported on the second National Energy Efficiency Action Plans and the first three years of application of the Directive, examine whether it is appropriate to come forward with a proposal for a directive to further develop the market approach in energy efficiency improvements by means of white certificates. The Commission's Energy Efficiency Action Plan also announces that a Community-wide white certification scheme is to be assessed. The workshop is designed and intended to feed into both the Commission's assessment and policy development process.

### **Workshop objectives**

The purpose of the workshop is to provide a forum for policy experts and stakeholders to review and discuss outcomes and results of existing energy saving obligations and white certificate schemes in Europe and beyond. The main objective of the workshop is provide for critical assessment of core design issues drawing upon experiences gained in the actual design, implementation and evaluation of existing European schemes, such as sectoral coverage of the schemes, category of obliged parties (suppliers or distributors), importance of trading and market set-up, cost-recovery mechanisms, and penalties for non-compliance. Furthermore, key issues such as cost effectiveness of energy savings delivered by these schemes, including the cost of implementation, should also be explored so as to contrast and compare white certificate schemes with alternative policy instruments designed to deliver the same outcomes. Finally, the workshop also wishes to address two topics that have received little attention to date: the potential effects and pros and cons of a Europe-wide white certificate scheme and the prospects and viability of voluntary markets for white certificates, possibly as an integral part of carbon markets.

The workshop will take place in Brussels on 31 March and 1 April, 2009. Sessions 1 will provide a critical assessment of existing energy saving obligations and white certificates from



the perspective of both policy makers and market stakeholders. Sessions 2 and 3 will explore possible strengths, weaknesses, threats and opportunities related to a Community-wide white certificate scheme as well as the viability in the absence of a Community-wide scheme being adopted of creating a voluntary market for white certificates, one that would eventually be an integral part of the carbon market. Three panel discussions will take place on 1 April. The workshop will be reserved upon invitation to a maximum of 80 participants, and there will be no registration fee. The second day of the workshop is sponsored, in part, by DIN, the German Institute for Standardization.
